Driver's License Test Schedule

Effective September 2015

Driver's license testing services are offered at the exam station locations listed on this schedule.

Knowledge (written) tests are given on a walk-in basis; no appointment is necessary. Depending on the exam site, the knowledge test may be offered on paper or on a computer. **Knowledge tests must be started 45 minutes prior to any closing time.**

Appointments are recommended for skill (road) tests and may be made by telephone, in person, or on our website at dvs.dps.mn.gov. If you are not on time for an appointment, the time will be given to someone else and you may be required to make another appointment.

- At locations without telephone service, you may call the examiners when they are at the exam station listed under <u>TELEPHONE</u>.
- If you need accommodations in the test facility or the testing process please contact your local exam station or call (651) 297-3298 (telephone) or (651) 282-6555 (TTY only).
- For the location and hours of the driver examination site nearest you, call (651) 297-2005 or go online at dvs.dps.mn.gov.
- To check to see if driving privileges are valid, call (651) 284-2000 or go online at dvs.dps.mn.gov. You will need your driver's license number.
- Reinstatement fees are collected during knowledge testing hours only.

Except as noted, knowledge tests are given continuously until 45 minutes before closing.

- * Knowledge tests are given only at 10:00 a.m.
- + Driver's license renewals and applications are accepted at these stations. **Persons making an application should arrive at least 15 minutes** prior to closing in order to complete the application, vision screening and have a photo taken.
- Enhanced Driver's License and Identification Cards are accepted at these stations. **Persons making an application should arrive at least 45 minutes prior to closing in order to complete the application process.**
- C Commercial Driver's License road tests are given ONLY at these stations. Appointments are recommended. CDL knowledge tests are given at all exam stations.
- Telephone may be answered during knowledge testing hours only.
- Oral tests scheduled with an interpreter are given ONLY at these stations.

Circumstances beyond our control may require schedule changes without prior notice.
