New Business

- a. FY 2016 Clean Water Fund SWCD Buffer Implementation & MAWQCP Implementation. Apply for \$30,000 for Buffer Implementation and \$6,000 for Ag Water Quality Certification. Motion by Meulebroeck, 2nd by Deuts to authorize staff to apply for grants. All in favor, motion carried. Discuss on TSP and working the MAWQCP grant into their program.
- b. Ben Ludeman Cost Share Assistance. Motion by Deutz 2nd by Meulebroeck to approve RCRCA to cover project. All in favor, motion carried.
- c. Aaron Swanson Cost Share Assistance. Motion by Deutz 2nd by Lavoy. Look for outside funding or use our own. Cost Share Eligible cost is \$1099.02 which is 75% of \$1465.36. Landowner cost is \$366.34. All in favor, motion carried.
- d. Dan Lanoue Cost Share Assistance Motion by Meulebroeck, 2nd by Lavoy. Look for outside funding or use our own. Cost Share Eligible cost is \$4,726.49 which is 75% of \$6,301.98. Landowner cost is \$1575.50. All in favor, motion carried.
- e. Dale Kesteloot Cost Share Assistance Motion by Prairie, 2nd by Meulebroeck. Cost Share Eligible cost is \$35,477.42 which is 75% of \$47,303.22. Landowner cost is \$11,825.81. All in favor, motion carried.

- f. Roger Ricke RCRCA Partnership Cost Share Partner with RCRCA. Total amount of the project is \$11,000. 75% allowed cost is \$8,250.00. RCRCA will be covering 44% for a total of \$4,811.77 and Lyon SWCD will be covering 31% for a total of \$3,438.23. The remaining \$2,750.00 will be landowner cost. Motion by Meulebroeck and 2nd by Gary to approve our portion of this project. All in favor, motion carried.
- g. Kent Weedman Payout RCRCA Funds. Initially approved for estimated cost of \$10,915.00. 75% of cost that was approved is \$8,186.25. A new bill came in at \$11,565.44. The landowner will cover the extra cost for a total amount of \$3,379.19. The cost share allowance will then drop to 71% instead of 75%. Motion by Deutz, 2nd by Lavoy to approve cost partnership with RCRCA to pay for project. All in favor, motion carried.
- h. Parks Work Relationship Steve Prairie to let Park Board know that we are willing to share equipment, services, etc. with the Parks Department.
- i. Meeting Time October 27, 2015 Due to harvest, the next meeting will be at 7:00 p.m.
