<u>District Report – John</u> – Buffer Work is almost complete. Public Waters, 30 ft min, 50 ft avg, 1226 compliant, 409 non-compliant based on 2015 maps. 296 compliant, 188 non-compliant on ditches which are 16.5 ft. This is due by November 1, 2017. Working with County on Jurisdiction by 3-31-17 and who would enforce compliance. List of names of non-compliance must be given to the agency doing the enforcement. 11 months will be allowed to be in compliance. \$100/ day for non-compliance. \$500/day after 180 days. Other waters list is due by 7-1-17 and must be adopted by 7-1-18.
