Danielle Evers MAWQCP Presentation-Program Updates of \$100 Application & Assessment Incentive, \$6000 additional funding through GBERBA for districts working on MAWQCP. \$5000 program grant available at 75% cost share through MDA. 2 free water quality inlets. Would like Lyon County to continue to implement MAWQCP.

FY 2018 & 2019 SWCD Programs & Operations Grant Agreement Discussion/Signature –Grant is for \$100,000 for 2018 SWCD Local Capacity Services. \$30,000 for 2018 Buffer Law, \$19,224 for 2018 Conservation Delivery.
