- **a.** Emily Javens Yellow Medicine Watershed District Maps for Terrain Analysis Presentation. Focus is on looking at maps to pinpoint erosion and runoff. Many opportunities for drainage water control within the watershed. Map from the presentation covered Lucas and Vallers Townships and the Cottonwood Lake Watershed.
- b. "Other Waters" Township Update- Todd and John attended Township Meeting. We have received some feedback from various townships. We will compile data as we receive it and continue to update the board with information. This is due by July 1<sup>st</sup>, 2017 for the Buffer Project.
- c. TSA Management and Structure Analysis-Handout from meeting. TSA differs across the state. This is the first analysis meeting. TSA is a joint powers agreement. UPDATE FROM HANDOUT
- d. MASWCD -2017 Resolutions Process-Talked if the Board would like to send in any resolutions. The deadline for Area resolutions is due by July 21, 2017.
- e. SWCD Governance 101 Training Conference-Handout for the New Supervisor Training. Will keep the board updated with new information as we receive it.

f. RCRCA Cost Share Approval – Don Girard Project- Motion by Deutz, 2<sup>nd</sup> by Laleman to approve 5% of total project cost of \$11,500. RCRCA will pay 70% in the amount of \$8,050, SWCD will pay 5% in the amount of \$575 and landowner will pay \$2,875.00.

<u>District Technician –Luke</u> –Technicians have been out surveying.

<u>District Report – John</u> – Meeting with the City of Balaton, Lake Yankton. The City would like to have the County implement the Shoreland Ordinances. Meeting will be coming up to possibly implement the shoreland changes. Tree matting machine is being used. Many new feedlots being built.

<u>District Conservationist – Lance</u> - No report. CSP is in process.
