- b. SWPTSA-2019 Local Share for NPEA Grant & Share Technical Services Invoice in the amount of \$3,400.00. It is 10% Local Share for NPEA Grant \$130,000 & Enhanced Share Technical Services \$240,000. Motion by Meulebroeck, 2nd by Laleman to approve the payment of the invoice. All in favor, motion carried.
- c. **FY 2019 SWCD Local Capacity and Buffer Law Implementation Grant Amendment** –FY 2019 SWCD Local Capacity Services Grant Amendment is for \$114,400.00. FY 2019 Buffer Law Grant Amendment is for \$70,000. Motion by Meulebroeck, 2nd by Prairie to approve the grant amendment and have Chairman Deutz sign the amendment document.
- d. **Soil Health –Café Chat** Will be held in Marshall on February 27, 2019, at the Pizza Ranch in the morning. Ben Dwire, Allen Deutz, Mike Erbes and Lyon SWCD Staff will be speaking at the event. They

- will be talking about how they are using cover crops land and how it is working for them. Lyon SWCD Staff will be sending out a flyer to CSP contracts recipients.
- e. **Legislative Letter** Biren composed a letter to Senator Dahms, Senator Weber, Representative Swedzinski and Representative Schomacker to thank them for their support. - f. **NACD Technical Assistance Grant for TSA** Grant is for \$125,000 with a match of \$25,000. Funds will be covered with Ryan and Olson in-kind hours. Motion to approve the NACD Technical Assistance Grant for TSA by Prairie, 2nd by Lanoue. All in favor, motion carried.
- g. John Albee and Virgil Johnson Waterway Cost Share Amendment Partial Payment Cost Share Amendment Motion to have the Cost Share Amendment amount of \$14,207.51 which is 75% of the total amount of \$18,943.35 by Prairie, 2nd by Meulebroeck. All in favor, motion carried. Motion to pay the Cost Share Partial Payment of 50% of \$18,200.85 in the amount of \$9,100.43. Albee's portion is \$7,317.00 and Johnson's is \$1,783.43 by Meulebroeck, 2nd by Laleman. All in favor, motion carried.
