PLANNING COMMISSION: A REQUEST HAS BEEN MADE by Jerome & Tanner Differding, Taunton, MN for a Conditional Use Permit request for a new feedlot and to hear public comment The land is zoned agricultural and described and located as the following:17.46 ACRES of the Northwest Quarter of the Southeast Quarter (NW 1/4 SE 1/4) of Section Three (3) Township One Hundred Thirteen (113), Range Forty-three (43), Eidsvold Township, Lyon County, MN.The Proposed Facility to Consist of: Finishing Hogs (2,400 x.3 animal factor)=720 Animal Units. Type of Building:(new) Approximately 100'x200' Confinement Barn with 8' deep below the barn concrete manure pit. Manure to be applied agronomically up to two times a year. The Total Animal Unit Capacity = 720 Animal Units

Steen moved, seconded by VanOverbeke to recommend to the Lyon County Board of Commissioners grant a Conditional Use Permit to Jerome and Tanner Differding, 3940 130th Ave., Taunton, MN, for a new feedlot and to hear public comment to fulfill Minnesota Session Law 2000 – Minn. Stat. § 116.07, subd 7 (I), to construct or expand a feedlot with a capacity of 300 animal units or more. Odor OFFSET setback requirement is 94%. Minimum setback for a new feedlot is 1320'. The land is zoned agricultural and located and described as 17.46 ACRES of the Northwest Quarter of the Southeast Quarter (NW 1/4 SE 1/4) of Section Three (3) Township One Hundred Thirteen (113), Range Forty-three (43), Eidsvold Township, Lyon

County, MN The Proposed Facility to Consist of: (New) Finishing Hogs (2,400 x.3 animal factor)
720 Animal Units. Type of Building: (new) Approximately 100'x 200' Confinement Barn with 8'
deep below the barn concrete manure pit. Manure to be applied agronomically up to two
times a year. The Total Animal Unit Capacity = 720 Animal Units With stipulations:
