- b. **2020 SWCD Board Meeting Schedule-Handout-**All Supervisors agree to keep meetings on Third Tuesdays at 7 p.m. Motion by Meulebroeck, 2nd by Laleman to approve the meeting schedule, all in favor, motion carried.
- c. City of Marshall Streambank Stabilization Project Discussion An engineer from the city wanted to see if the SWCD would have cost share funds available to do Streambank Stabilization by the Swimming Pool and one by Legion Field. Staff brought to Supervisors to see if they want to proceed further with funding. Recommendation to check with City to see if they can look into grants or funds from other entities. Supervisors stated that Staff can assist with design, but not funding at this time.
- d. **GBERBA-Project Updates –Handout –** Projects, Workload and Events handout and also Year to Date Numbers from Area 5 Applications, Assessments, Certification.
- e. #03/19 Patzer/Snodgrass- Amendment to Cost Share Voucher Approval Invoice increased due to adding more fill. Total cost is \$ 51,694.00. \$25,000 is being paid for by County Riparian. Total of \$13,770.50 which is an additional \$8,770.50 on top of \$5,000.00 already approved. Motion by Meulebroeck to amend the contract, 2nd by Laleman. All in favor, motion carried.

- f. #03/19 Patzer/Snodgrass -Cost Share Payment Approval Total of \$13,770.50 which is an additional \$8,770.50 on top of \$5,000.00 already approved. Motion by Meulebroeck, 2nd by Prairie to pay cost share voucher of \$13,770.50. All in favor motion carried.
- g. #13/19-Steve Prairie Cost Share Payment Approval- Total cost is \$4,712.50. 75% cost share amendment is \$2,831.22. Total landowner cost is \$1,881.28. Motion by Meulebroeck 2nd by Lanoue to approve Cost Share Voucher for lined waterway. All in favor, motion carried
- h. #28/19 Jim Vandendriessche Cost Share Payment Approval- Total cost of \$8,291.70. 75% cost share is \$6,218.78. Total landowner cost is \$2,072.92. Motion by Prairie, 2nd by Laleman approve Cost Share Voucher for basin. All in favor, motion carried
- i. #08/18 Frank Engels Partial Cost Share Payment Approval 75% cost share is \$3,093.75 for Earthwork and Tile of Basin 1B. Basin 1A is not completed and has 75% cost share of \$1,660.50 left to pay. Motion by Meulebroeck 2nd by Prairie to approve partial payment of Cost Share Voucher. All in favor, motion carried.
- j. #09/18 Kevin Grimes Amendment to Cost Share Voucher Approval Amendment to reflect quoted price for narrow basin base construction and end block constructions costs. Estimated total was \$16,050.93. 75% Cost share is \$12,038.20. Landowner cost is \$4,012.73. Motion by Prairie, 2nd by Laleman to approve amendment of Cost Share Voucher. All in favor, motion carried.

 #09/18 Kevin Grimes Cost Share Payment Approval- Total cost of \$17,867.00. Partial payment of \$5,885.25 has been paid for tile. Final payment of \$4,425.00 cost share voucher based on \$5,900.00 off of quoted narrow base basin which is \$10,310.25, 57.7% of total bills. Landowner cost is \$7,556.75.

 Landowner pursued farmable base basin construction with known extra earthwork costs. Per SWCD Policy, SWCD Board approves only on narrow base basin construction costs. Motion by Prairie, 2nd by Laleman to
- k. #06/19 –Leland Bush Cost Share Payment Approval- Total cost of \$15,697.99. 75% cost share is \$3,335.81 after EQIP payment of \$10,695.00. Landowner cost is \$1,667.18. Motion by Meulebroeck, 2nd by Laleman to cost share voucher of \$3,335.81. All in favor, motion carried.
- Per Diems Update –Handout Per Diem can only be up to \$75.00 per day, plus expenses and mileage per State Statute.
- m. **Grant Funds Update -** Originally Encumbered funds were reorganized to ensure grant spenddown as follows:
 - Frank Engels Funds were moved to 2017 Conservation Delivery for \$3,093.75 with the remainder of \$1,660.50 coming out of 2018 State Cost Share.
 - Jim Vandendriessche Funds were moved to 2017 State Cost Share for \$382.61, \$4993.35 out of 2017 Local Capacity and \$842.79 out of 2019 Local Capacity.
 - Steve Prairie Funds were moved to 2017 Conservation Delivery \$993.59, \$1,756.42 out of Conservation Delivery, \$3.66 out of 2017 State Cost Share and \$77.55 out of 2019 Local Capacity.

Updates to the Local Capacity Work plans for 2017, 2018 & 2019 will be updated to reflect the changes.
