- a. **MASWCD Legislative Briefing and Day at the Capitol** The 2020 MASWCD Legislative Briefing and Day at the Capitol will be held on March 24-25, 2020 at the Best Western Plus Capitol Ridge in St. Paul.
- b. **2020 IRS Standard Mileage Rates Handout –** The IRS 2020 Standard Mileage Rate will be 57.5 cents per mile down from 58 cents per mile in 2019.
- c. **MASWCD 2020 Dues Handout and Approval –** MASWCD 2020 Dues are \$3,844.23. Motion by Deutz 2<sup>nd</sup> by Prairie to pay dues in the amount of \$3,844.23. All in favor, motion carried.
- d. **SWPTSA 2020 Local Share for NPEA Grant & Shared Technical Services -**2020 10% Local Share for NPEA Grant and Enhanced Shared Technical Services is \$3,400.00. Motion by Meulebroeck 2<sup>nd</sup> by Deutz to pay dues in the amount of \$3,400.00. All in favor, motion carried.
- e. **Peterson Company LTD. Audit Bid Letter Handout and Approval** Audit Bid Letter in the amount of \$2,850.00 for 2019 Audit. Motion by Prairie 2<sup>nd</sup> by Deutz to hire Peterson Company LTD in the amount of \$2,850.00 to completed 2019 Audit. All in favor, motion carried.
- f. Water & Sediment Control Basin and Grassed Water Policy -- Handout and Discussion
  - 75% is a good carrot to get projects done.
  - YM1W1P pays up to 100 percent to help entice projects in priority areas especially with non-willing land owners.
  - May free up local money if the EQIP program is pursued first.
  - Going up to 90 or 100 percent is not going to help get more projects done.
  - Consideration for higher payment when the project will enhance more than just their own property.
  - A two-tiered system with EQIP may be good.
- g. #19/19 –Jim Opdahl Cost Share Payment Approval Cost Share Payment in the amount of \$16,322.04 which is 75% of the total of \$21,762.72. Landowner amount is \$5,440.68. Motion by Meulebroeck 2<sup>nd</sup> by Lanoue to pay cost share payment in the amount of \$16,322.04. All in favor, motion carried.
- h. **Local Capacity Contracts Discussion –** Originally Encumbered funds were reorganized to ensure grant spend down as follows:
  - #04/19 -Charles Klukas North Basin –Contract Cancellation Total cost of %5,296.57. 75% cost-share split: \$1,049.20 from FY 2018 Local Capacity Service and \$2,923.32 from FY 2019 Local Capacity Services. Motion by Meulebroeck ,2<sup>nd</sup> by Deutz to cancel cost-share contract for \$3,972.52. All in favor, motion carried.
  - #05/19 -Charles Klukas South Basin Contract Cancellation Total cost of \$11,393.22. 75% cost-share is \$8,544.91 from FY 2019 Local Capacity Services. Motion by Meulebroeck, 2<sup>nd</sup> by Deutz to cancel cost –share contract for \$8,544.91. All in favor, motion carried.
  - #30/19Spencer & Brook Kor Contract Cancellation Total cost of \$32,000. 75% cost-share split: \$10,152.71 from FY 2018 Local Capacity Services and \$13,847.29 from FY 2019 Local Capacity Services. Motion by Meulebroeck, 2<sup>nd</sup> by Deutz to cancel cost –share contract for \$24,000. All in favor, motion carried.
- i. **Summer Intern** –Meulebroeck moved, 2<sup>nd</sup> by Lanoue to pursue summer intern by utilizing Carolyn McDonald, Lyon County HR. All in favor, motion carried.
