 A VARIANCE REQUEST has been received by the Lyon County Planning and Zoning Administrator by Clark Family Farm LLC, C/O Kelly Jones, 700 Kennedy Street, Marshall, MN 56258 to construct a home 45 feet from the road right-of-way. The required setback is 100 feet from the road right of way. This request represents a 55-foot variance. Property address is 2166 County Road 74, Lynd, MN 56157. The land is zoned Agricultural and is described as:
