**RCRCA** • 16th MN River Congress - 6:00 PM Kato Ballroom – Mankato. The agenda includes a history of the Isaak Walton League Upper Mississippi Initiative, Successes of MN River Collaborative Actions (Lyon CD 14, YM CD 9, Limbo Creek, etc.), Water Storage Program update, and potential collaboration of state agencies for water storage. I plan to attend the meeting and will report back.

• <u>Cottonwood-Middle MN 1W1P</u> The Steering Team and Policy Committee met on May 15 at the Springfield Area Community Center and reviewed the draft of the full plan, minus the Executive Summary, Table of Contents and Appendices. Netzke emailed links to the full plan and appendices on May 30 to the Steering Team, Policy Committee, and Advisory Committee with comments due June 14. These committees will meet on Monday, June 24 to review/discuss edits. Formal 60-Day Review will start July 1.

Implementation will be administered by a Joint Powers Agreement. Two options exist: a stand-alone agreement like the Des Moines or utilize RCRCA's existing JPA. Partners were asked to discuss their wishes with their respective Boards. If RCRCA's JPA is chosen, the RCRCA Board will approve cost-share contracts monthly as part of their normal board meeting as recommended by the Technical Committee for the Cottonwood-Middle MN. The JPA would need revision to include the "orphan" areas outside of the Redwood and Cottonwood watersheds.

# • 2024 Canoe Trips [pending river flow conditions]

Tuesday, June 18: Redwood River – County Road 6 to Lake Redwood. Lunch at Perk's Park at Lake Redwood. Thursday, June 20: \*NEW ROUTE\* Cottonwood River – Soldiers and Sailors Park at Sanborn to Riverside Park in Springfield. Lunch at Shelter 2 in Riverside Park.

There is a log jam in the river that is not passable by the Springfield Golf Course. RCRCA contacted DNR as this is a designated canoe route and is required to be passable. MN Conservation Corps contacted RCRCA and reported that this is a large jam and they do not have chainsaws large enough for some of the trees. They will return when water levels are lower.

Netzke contacted Mathiowetz Construction Company for drone footage and to determine if an excavator could reach enough of the trees to make it passable by June 20. Mathiowetz responded that some additional trees along the north bank would need to be removed in order to maneuver the excavator. He anticipates 2 full days at a cost of \$5000-\$6000.

RCRCA is lining up helpers to assist the canoes and kayaks to portage around the log jam.

#### **Area II River Basins**

- Yellow Medicine Watershed Pilot Water Storage Project The 5th meeting was held June 10, 2024. 33 potential projects have been identified which would reduce the 100-year peak flow by 5%. It was noted that the existing retention structures have been located well and are doing a good job at reducing peak flows. A technical meeting is being arranged to illustrate how to use the model under different scenarios.
- <u>Water Quality & Storage Grants</u> BWSR announced the awards on May 22. Area II's applications ranked 4th, 5th, 6th, 7th, and 9th. The top 5 were funded including North Hero 34 Road Retention (\$867,549.51) in Redwood County and Holly 22 Road Retention (\$555,770.38) in Murray County. Netzke completed the Work Plans in eLINK and is awaiting the grant agreements.
- **Area V** Next meeting in June 14<sup>th</sup> in Windom includes Jeffers Petroglyphs tour.
- SW Prairie TSA Next meeting is on June 24<sup>th</sup>. Coordinator Report Possibility of hiring another Engineering Technician. Houston Engineering will be completing a Workload Analysis. Purpose is to prepare a workload/technical analysis.
- Park & Rec Garvin Park Restrooms almost available. May 16<sup>th</sup> meeting. Archery Deer hunting permits approved. Looking at a couple of different grant applications, one for electrical upgrades and the other for HELP Prairie Restoration Grant.
- **Yellow Medicine Watershed** Starting at 8 a.m. now instead of 10 a.m. Perennial planting flat rate of \$100/ac
- One Watershed One Plan (Yellow Medicine) No meeting.
- One Watershed One Plan (Des Moines) Giles attended June 12<sup>th</sup>.
